- It was also agreed that we should urge Kerry and Shaun to consult and possibly involve interested or affected community members in the detailed planning of Action Plan priorities. Too much detail in the action plan may limit options given possible changes in local conditions over time

Liz thanked Ron for his response and welcomed news of CCS/DPTI plans to install lighting in 2016-17, though noted that cyclists felt unsafe on the path in the dark even though thankfully there hadn't been reports of assaults on cyclists or pedestrians on it.
